AND

Where the author/founder is interested and desirous to create a public educational/charitable welfare trust in order to promote and encouraged general, medical and technical education in the society and to make proper arrangement to educate the people/ student of the society and to do general welfare works for the people. And where as in pursuance of the said desire and of carrying out the same into effect the Author named above has settled presently a sum of Rs. 11,000/- (Rupees Eleven thousand) only to being with be extending humanitarian services including educational or any activity of general public welfare, the trustees by way initial Trust Fund with assurance to donate and mange the further amount, if any when the same would be required and as would be possible and convenient to the author.

And whereas the Trustees will utilize the fund of the Trust including all accumulation and accretion therein the manner and for the purpose hereinafter mentioned.

NOW THIS DEED OF TRUST WITNESS AS UNDER

1. Name

The name of the Trust hereby established shall always be " N. P. Educational and Welfare TRUST" and the same shall never be changed.

2. Office

Principal Office of the Trust shall be at Kapila Enclave, Chirachas , P.S. Chas, Distt. - Bokaro in the state of Jharkhand.

3. Jurisdiction:

The Jurisdiction of the trust shall extend to the State of Bihar and Jharkhand.

4. Aims and objects :

The aims and objects for which the trust is created and for which the Trust Fund may be utilized are as follows:

- (i) To render services in the field of education to children and youths, irrespective of the caste, creed, race, religious language or social status.
- (ii) To open establish, manage, control and run general, technical, vocational and medical, educational institutions such as Medical College, Law College, Teacher's Training College, Business Administration College and computer Application Colleges including schools from nursery to higher secondary standard, Graduation and PG colleges, Engineering College and other associated institutions through out the state of Bihar and Jharkhand
- (iii) To engage Teachers/ professors, scholars and educationalists of high proficiency to impart efficient education and vocation to students.
- (iv) To establish, maintain and run boarding houses, residential, educational institutions and hostels for the students and persons connected with educational institutions.
- (v) To organize open and conduct libraries Reading rooms etc. for the students of all disciplines.
- (vi) To pay out such stipends and scholarship to the poor and meritorious students and research scholars as the trustees may deem fit considering the income of state states and income of the Trust Estate.
- (vii) To organize and conduct tours and excursion as a part of curricula to the students to equip them with up to date knowledge and to develop the incentive and research faculties of the student, teachers and others associated with the establishment of this Trust.
- (viii) To receive and collect any gift, subscription and donation either in cash or in kind or by way of any lawful means and spend the same for fulfillment of all or any of the aims objectives of the Trust, The income and properties of the Trust shall solely be utilized for the promotion and fulfillment of all or any of the aims and objectives of the Trust.
- (ix) To acquire by purchase or by gift or to take on lease, hire, or otherwise hold any movable or immovable property or any right or useful for the advancement of the objectives of the Trust.
- (x) To do all such other lawful acts, deeds and things which are incidental and conductive to the attainment of all or any of the objectives of the Trust.

Trust Properties :

The author of the trust hereby vests finally and irrevocably a sum of Rs. 11,000/- (Rupees Eleven thousand only). The aforesaid sum will be initial fund of the Trust. Any further sum received in the form of money or money's worth by way of donations, gifts, grants or acquired by any other mode by the Trust, will be the property of the Trust , movable of immovable shall vests in the trustees only.

4. Board of Trustees :

- (a) The administration, management and control of trust and it properties shall vest in the hands of committee to be called the "Board of the Trustees" consisting of persons for the time being and shall be carried on in accordance with the rules as may be framed and modified from time to time by the said Board of Trustees whose names, address and descriptions are subscribed above and.
- (b) The trustees shall hold office during their life time unless any of them desire to be discharged of his duties or becomes mentally and physically incapable or working. A trustee who is an under charged insolvent or who has been convicted of any offence in connection with the formation, management of the affairs of the Trust or of any offence involving moral turpitude or of a criminal offence shall not be entitled to be trustee and such member shall be deemed ousted from the Board of Trusts.
- (c) In the event of a vacancy arising in the Board of Trustees for voluntary retirement, incapability of working etc. the remaining trustees shall co-opt. another major male or female persons according to the decision of the majority of the remaining trustees to fill up the vacancies preferably out of the family members of that particular trustee.
- (d) The number of trustees shall at no time be less than three and more than eleven.
- (e) The trustees shall work in an honorary capacity but they may reimburse themselves or pay or discharge out of the trust property all expenses properly incurred in or about the execution of the trust property or the protection or support of the beneficiary. No trustee shall be entitled to take loan on behalf of the Trust or to tale any advantage of himself or any member of his family in whatever form to manner from the Trust.
- (f) A trustee who by his conduct as trustee or in his personal life adversely reflects on the reputations of the trust may be asked by the Board of trustees by a resolution passed by a majority to submit his resignation failing which shall cease to be a Trustee with effect from the date of passing of such resolution .



The next meeting will be called within an hour with some agenda in which no quorum will be required.
- (iii) The trustees may pass a resolution by circulation, such resolution passed whether by majority or unanimously by circulation amongst if passed at a meeting duly called and conveyed for the purpose and such resolution shall be entered by the Chief Managing Trustee in the minute book of the meeting of the Trustee.



for the meeting, the trustees will elect president for the meeting among available trustees. The decision of the meeting shall be recorded in minutes, entered into a special book maintained for purpose duly signed by the president of the meeting.

- (vii) The Trustee shall act according to the decision of the majority of the Trustee. When the Trustees are not unanimous on any issue/resolution, the Chief Managing Trustee (Chairman) shall have the casting vote in case of a tie. The decision of the meeting including the election of trustees shall be taken by show of hands or secret ballot as the Chairman may desire by majority of the votes of the members present.
- (viii) The Chief Managing Trustee shall guide and supervise the various activities of the trust. The ruling of the Chairman at the Board of Trustees shall be final and binding on all question raised. The chief managing trustees shall be empowered to establish local managing or governing body and established by the Trust.
- (ix) The Chief Managing Trustee shall be executive officer of the council of Trustee. He or she shall carry on the administrative work of the trust, receive all letters and documents addressed to the trust, prepare correspondence, and keep all books and records of the trust, he shall collect all dues of the trust and effect all its payments, keep appropriate records and books and help the council of trustees in financial administration of the Trust.

8. **Financial :**

The financial year of the trust shall commence from 1st April and close on 31st March of every years.

9. **Bank Account:**

The trustee shall open Bank account or accounts in the name of the trust in any Nationalize Bank which will be operated by joint signature of the Chief Managing Trustees and one of the Trustees authorized by the Board of Trustees.

10. **Books & Accounts & Audit ;**

The trustee shall maintain proper books of accounts. They will be audited annually by Chartered Accountant appointed by the Board of Trustees fixing his remuneration.
